## RENTAL AGREEMENT

**By signing this Contract, I agree to rent from, X-Quisite Rentals, the equipment listed for the price and length of time indicated on the contract subject to the following terms and conditions.**

1. I agree to respect all of the equipment and use it in a proper manner.
2. I agree to return the equipment with all attachments, accessories and parts to, X-Quisite Rentals in the same condition as originally received.
3. If any of the equipment is lost, destroyed or damaged, I promise to pay, X-Quisite Rentals in cash its full replacement or repair value. I understand that X-Quisite Rentals will immediately apply any deposit or credit card pre-authorization towards the replacement value and/or overdue fees.
4. If at any time the equipment becomes unsafe or is in a state of disrepair, I shall immediately stop using the equipment and notify, X-Quisite Rentals immediately that the equipment is unsafe and in disrepair. I further agree to take all steps necessary to prevent injury to any person or property until possession of the equipment is returned to, X-Quisite Rentals. After hours notifications can be left on the general voice mail box.
5. X-Quisite Rentals does not refund or change any policies due to weather or other, "Acts of God".
6. If I wish to rent the equipment for additional time, I agreed to notify, X-Quisite Rentals and obtain prior written approval. Applicable additional rental fees will apply. I agree to pay an additional rate for all overtime the equipment is in my possession.
7. I agree not to sublease any equipment I have rented through, X-Quisite Rentals.
8. I agree to hold, X-Quisite Rentals harmless for any claim for damages or injury which may arise out of the use, possession or malfunction of the equipment. If the equipment has been used improperly or in an unsafe manner or used for something other than its intended use, I agree to pay all charges associated with the Contract, including reasonable collection fees, attorney's fees, court costs or any other expense incurred by, X-Quisite Rentals to enforce the terms of this Rental Agreement.
9. All rentals are based on a 72 hour rental period. Longer term rates are available for an additional fee.
10. Refunds will not be applied on rentals whether used or not once they have left the warehouse.

11. A charge will be added for any items requiring excessive cleaning upon return.
12. All cancellations are refundable prior to 30 days of the order date.
13. All orders cancelled within 30 days of the order date are subject to a 25% cancellation / restocking fee.
14. All orders cancelled upon delivery will not be refunded.
15. I agree to pay a deposit of, 50% of the rental rate to reserve the rental items. The balance is due two days prior to the pick up or delivery.
16. Order Confirmation: Orders MUST be confirmed with a signature on the reservation and full payment to initiate preparation of the order. Orders will not be pulled or prepped until client's signed reservation is received along with a signed copy of this rental agreement and payment.
17. Inspection: Customer is responsible for inspecting all props, furniture and equipment upon taking possession, including instances where a client has subcontracted an outside carrier to manage pick up and delivery. Customer or their agent is to report any discrepancies immediately to the, X-Quisite Rentals staff. X-Quisite Rentals will make their best possible effort to remedy the situation as soon as discrepancies are reported. However, X-Quisite Rentals shall not be liable to lessee for any loss, damage or liability resulting from the use of its rental property or from the condition of said property.
18. Packing materials: Customer is responsible for return of all slipcovers, blankets and dollies or replacement charges will apply. Customer is responsible to pack all equipment in the manner it was received.

The, "Customer" as set forth in the terms and conditions stated above, agrees to pay for all services and equipment provided by, X-Quisite Rentals. This includes all breakage, loss and additions made by the Customer and its agents. The Customer agrees to the Terms and Conditions set forth above which are expressly incorporated in all invoices from, X-Quisite Rentals.
